Please find attached Appendix 4C for Neuren Pharmaceuticals Limited for the first quarter ended 31 March 2010.

The results presented are consistent with the Company's expectations based on previously announced business plans.

As previously announced, Neuren has a convertible loan facility in place and drew down A\$600,000 in the quarter. This facility is available until December 2011 and provides minimum monthly funding which commenced with A\$400,000 in January 2010, followed by ten tranches of A\$100,000, and subsequent tranches of A\$60,000.

Neuren also continues to receive grant funding from the US Army towards the direct costs of the Phase 2 trial of NNZ-2566 which is about to commence. The Company periodically requests and receives in advance funding instalments to meet trial costs expected to arise within the next one or two months, and this process will continue through the course of the Phase 2 trial.
